Hot surfaces – burns and scalds	Child/adult	The hot plate for drying the paper once it has been made will be placed out of children's reach and clearly labelled as being hot. The glazing machine is behind the hot plate, even further out of children's reach.		L
Allergic reaction to materials	Child/adult	Schools are asked to identify children with any particular needs.		L
Exposure to bacterial / hazardous substances	Child/adult	Leader gives verbal warning at start of each session Leader instructs class to wash hands after the session		L

Risk assessment

Abuse from staff and others	Child/adult	Child protection policy in place. Staff and volunteers working with children should be CRB checked and have certificates to prove it.		L
Crushed fingers/hands when caught in glazing machine	Child/Adult	Leader gives verbal warning at the start of the session. Glazing machine is out of reach of the children.		
Crushed fingers - press	Child Adult	Users warned of risk to crushed fingers when press is used to extract water from paper. Leader always supervises activity with only one child at a time. Ensure both hands are on the press handle at time of turning, ensures safety to user.		L
Electrocution	Child/Adult	Cables and the hot plates are regularly pat tested and out of reach of the children.		L
Covid 19 contamination - general	Child/Adult	Masks worn in line with government guidance, QR codes, hand wash stations and group size managed across the site.		L
Covid 19 contamination specific	Child/Adult	Papermaking remains as demonstration only until such time as the government restrictions are lifted. Risk of contamination via hand vats minimized by use of hand wash before and after use, and the application of tight fitting disposable gloves during production. Visitors verbally warned of potential risk.		L
